# **Behavior Policy & Code of Conduct**

Ultimate Taekwondo Center (Team UTC) is committed to providing a safe, respectful, fun, and structured environment where all campers can learn, grow, and enjoy their summer experience. This Behavior Policy outlines expectations for all campers and the procedures used to maintain a positive camp culture.

### **1. Core Values**

Respect – for instructors, staff, fellow campers, property, and themselves.

Discipline – following rules, instructions, and camp routines.

Safety – acting in ways that protect themselves and others.

Integrity – being honest and taking responsibility for actions.

Teamwork – supporting and encouraging one another.

### **2. General Behavior Expectations**

Campers must:

Follow all instructions from instructors and camp staff immediately.

Treat all campers and staff with courtesy and respect.

Use appropriate language at all times (no profanity, insults, or teasing).

Keep hands, feet, and objects to themselves unless instructed otherwise.

Participate positively in all activities.

Stay within designated camp areas unless supervised.

Care for camp equipment, facilities, and personal belongings.

### **3. Safety Rules**

No physical aggression, roughhousing, or horseplay.

No bullying, harassment, intimidation, or exclusion.

No dangerous behavior (running indoors, throwing objects, climbing on furniture, etc.).

Follow all Taekwondo safety protocols during training sessions.

Wear proper camp attire and footwear as required.

Report any injuries, unsafe conditions, or concerns to staff immediately.

#### **4. Technology & Personal Items**

Personal electronics are not allowed at camp. This includes phones, tablets, smart watches, gaming devices, and similar items.

Any personal electronics brought to camp will be confiscated for the day and returned at pick-up.

#### **This policy is non-negotiable.**

Team UTC is not responsible for lost, stolen, or damaged personal items.

Toys, trading cards, and valuables should be left at home.

#### **5. Progressive Discipline Policy**

##### **General Behavior Issues**

Handled using verbal warnings, brief time-outs, and parent/guardian notification as needed.

##### **Physical & Verbal Aggression — Three-Strike Policy**

Strike 1:

Verbal warning and immediate removal from the activity.

Strike 2:

Parent/guardian notification and behavior review.

Strike 3:

Immediate dismissal from camp with no appeal and no refund.

#### **7. Respect for Staff & Authority**

Campers must comply with instructions from all instructors and staff.

Disrespect, defiance, or refusal to follow rules may result in disciplinary action.

Parents/guardians are expected to support camp policies and staff decisions.

#### **8. Parent/Guardian Responsibilities**

Review this policy with their child.

Reinforce appropriate behavior expectations.

Provide accurate emergency contact information.

Communicate any special needs, behavioral concerns, or medical issues.

#### **9. Refund & Dismissal Policy**

No refunds will be issued for suspension or dismissal due to behavior violations.

Team UTC reserves the right to remove any camper whose behavior disrupts the camp environment or compromises safety.

#### **10. Acknowledgment**

# **Enhanced Consent, Liability Waiver, and Release of Claims**

I, the undersigned parent or legal guardian ("Parent/Guardian"), on behalf of myself and my minor child ("Participant"), hereby acknowledge that participation in the Ultimate Taekwondo Center (Team UTC) Summer Camp and related activities involves inherent risks, including but not limited to physical injury, illness, permanent disability, emotional distress, property damage, or death.

## **ASSUMPTION OF RISK**

I knowingly and voluntarily assume all risks, both known and unknown, foreseeable and unforeseeable, associated with my child's participation in all camp activities, including Taekwondo training, physical conditioning, recreational activities, swimming/pool activities, transportation to off-site activities, and any other events conducted by or on behalf of Team UTC.

## **RELEASE AND WAIVER OF LIABILITY**

I hereby fully and forever release, waive, discharge, and covenant not to sue Ultimate Taekwondo Center (Team UTC), its owners, directors, officers, instructors, staff, volunteers, agents, contractors, affiliates, sponsors, landlords, insurers, and representatives (collectively, the "Released Parties") from any and all claims, demands, actions, causes of action, damages, losses, costs, and expenses of any kind, whether known or unknown, arising out of or related to my child's participation in the Summer Camp, including but not limited to claims based on negligence, premises liability, or negligent supervision.

## **INDEMNIFICATION**

I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, demands, damages, losses, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or related to my child's participation in camp activities or my breach of this agreement.

## **MEDICAL AUTHORIZATION**

I authorize Ultimate Taekwondo Center and its representatives to obtain emergency medical treatment for my child if deemed necessary. I agree to be financially responsible for any and all medical expenses incurred as a result of such treatment. I certify that my child is physically fit to participate and has no medical condition that would prevent safe participation except as disclosed in writing.

## **BEHAVIOR & DISCIPLINE POLICY ACKNOWLEDGMENT**

I acknowledge that I have read and agree to comply with the Team UTC Behavior Policy & Code of Conduct. I understand that violation of camp rules or unsafe behavior may result in immediate dismissal without refund.

#### **PHOTO & VIDEO RELEASE**

I grant permission for Ultimate Taekwondo Center to use photographs or video recordings of my child taken during camp activities for promotional, marketing, and educational purposes without compensation.

#### **SEVERABILITY & GOVERNING LAW**

If any provision of this agreement is held invalid or unenforceable, the remaining provisions shall continue in full force and effect. This agreement shall be governed by and construed in accordance with the laws of the State of New York.

#### **ACKNOWLEDGMENT AND SIGNATURE**

I have carefully read this agreement, fully understand its contents, and voluntarily agree to its terms. I understand that by signing this document, I am waiving certain legal rights on behalf of myself and my child.
